EIOPA list of identified insurance groups for which a college of supervisors is in place¹

- including relevant groups where the Swiss Financial Market Supervisory Authority (FINMA) participates in Colleges²

As per 30 November 2015

The list of groups for which a college of supervisors (college) is in place aims at increased transparency towards amongst others supervised insurance groups and ensuring that also non-EEA supervisors are aware of the existence of a college for a particular group.

In order to have a full overview of financial groups active in European supervisory arrangements, EIOPA also recommends that the list below should be read together with the list of identified financial conglomerates^{3.} (updated on an annual basis and reported to European Commission by the Joint Committee of the European Supervisory Authorities).

It should be noted that the list addresses groups which have a head office and activities in the EEA and in Switzerland. The list gives information of the countries where the significant branches of the group are situated. Since 1 January 2011 EIOPA is part of the established colleges. The European supervisory arrangements presented below do not preclude organisation of additional colleges on a worldwide level.

¹ The list reflects the status as of 30 November 2015 and is updated annually by EIOPA as changes in the list occur on an ongoing basis (mergers, acquisitions, sales, organisational transformations). It is based on provisions of the Helsinki Protocol (Protocol relating to the collaboration of the supervisory authorities of the Member States of the European Union with regard to the application of Directive 98/78/EC on the supplementary supervision of insurance undertakings in an insurance group). As off 2016 TITLE III - supervision of insurance undertakings in a group - of the Solvency II regulation is applicable. This will not have an impact on the identification of identified insurance groups.

² This list covers also relevant groups where the Swiss Financial Market Supervisory Authority (FINMA) participates in colleges of supervisors. Supervisory cooperation between EIOPA Members respectively EIOPA and FINMA is based on a Multilateral Memoranda of Understanding, which have been in place since 2005 resp. 2012.
